**The Gathering, October 23, 2018**  
**Diving Into the Past: Early U.S. Underwater**

The October Gathering featured a fascinating discussion with archaeologist Dr. Dave Thulman. He began his quest on under water archaeology in 1995 near Tallahassee, FL, seeking signs of the earliest inhabitants in North America.

By way of background, he introduced the audience to the Holocene geological age, the current geological period dating from about 11,650 years ago when the Ice Age, which lasted 2 million years, began to end. In the Ice Age, Florida was a drier and less hospitable place, with lower sea levels, in contrast to the wetter modern environment. Sinkholes were often the source of water and a place today to find the remains of mammoths and mastodons and indications of human carvings on those bones. That is where this presentation begins to focus.

As the Ice Age ended, current theory suggests that there was a land bridge formed between Russia and Alaska about 20,000 years ago that allowed migration into North America. DNA studies of Native Americans suggest a common ancestry from these migrations about 13,500 years ago. In the mid 1930s, archaeologists discovered human remains near Clovis, NM, and a distinctive stone-shaped spearhead known as the Clovis point. The Paleo-Indian peoples of North America were considered the Clovis people. It was hypothesized that all of the peoples in North America came via the land bridge about that time.

Dr. Thulman introduced us to the concept of pre-Clovis archaeology, seeking information about the period between establishment of the land bridge and the evidence of the Clovis migration. Today, remains are beginning to be uncovered that indicate human presence in North America earlier than Clovis (hence Pre-Clovis). That is the exciting work that Dr. Thulman and others are pursuing in Florida and other sites in North America. For example, according to Dr. Thulman, the Page-Ladson site on the Aucilla River south of Tallahassee has changed the way we think about early people in North America. Beginning in 1959, divers have discovered fossil remains that show signs of human cuttings on bones that date to 14,500 years ago.

We are just at the beginning of exploring the very earliest signs of humans in North America, which extend our knowledge of habitation by humans by an additional 1,500 years or more. The idea of underwater explorative archaeology is also providing new sources for research. In response to closing questions, Dr. Thurman mentioned that pre-history research is also continuing in the Chesapeake Bay region. Perhaps that could be the source of a field trip by would-be archaeologists of Falcons Landing—Dr. Thulman may have some suggestions. The evening provided an interesting presentation and discussion, thanks to Dr. Dave Thulman.

## Veterans' Day Celebration, November 12, 2018

On behalf of the Falcons Landing Chapter of the Military Officers Association in America (MOAA), Jim Mullen, President, welcomed approximately 150 guests on November 12 to this year's Veterans Day Celebration. In attendance was Barbara Brannon, President and CEO of Falcons Landing Military Officers Retirement Community. The event was held in the Ballroom at Falcons Landing and was also televised on channel 1970 for the benefit of the residents in the Johnson Center and West Falls who were unable to attend.

After the Presentation of the Colors by members of the Boy Scout Pack 956, Jim Mullen, led the guests in the Pledge of Allegiance and the singing of the *National Anthem*. Chaplain Jeff Payne followed with the Invocation.

Howard Schue was the first speaker. He summarized the History of the Veterans Day, formerly known as Armistice Day. This year, the world commemorated the 100<sup>th</sup> anniversary of the Armistice that ended the fighting in World War I on the eleventh hour of the eleventh day of the eleventh month (November 11, 1918). In 1954, President Eisenhower signed into legislation designating November 11 as Veterans Day honoring veterans of all wars.

Bob Manning continued the program by showing a video entitled "What is a Veteran". Following tradition, he then asked the veterans in attendance to stand and be recognized as their service song (Army, Marine Corps, Navy, Air Force, and Coast Guard) is played. The distribution of veterans by service affiliation at Falcons Landing was not surprising: Air Force, 38%; Navy, 26%; Army, 24%; Marines, 5%; DOD and other Government organizations, 7%. The guests ended this segment of the program by joining Kate Smith in her original recording of *God Bless America*, composed by Irving Berlin.

Howard Schue returned to the podium to begin the solemn portion of the program. He discussed the national program *Bells of Peace* and the significance of the ringing of the bells 21 times. The 21 tolls of the bell symbolize the nation's highest honor. It is based on the 21-gun salute. He requested that as the bells tolled, all in attendance would respectfully remember the veterans who have died serving our nation. A moment of silence continued during the playing of Taps. Earl Hunigan concluded the program with the Benediction.

**The Gathering, November 15, 2018**  
**30+ Years of Air Warfare and Future Wars**

The audience at the Nov. 15 Gathering heard Lt. Gen., USAF (Ret) Dave Deptula discuss his first hand perspective of recent past Air Warfare planning and execution starting with the Operation Desert Storm air campaign in 1991 and continuing forward 10 years to the opening stages of Operations Enduring Freedom (Afghanistan) and Iraqi Freedom that provided some new insights on Air Force planning. Gen Deptula then discussed the recent air campaign against the Islamic State and provided a perspective with insights from the earlier air campaigns. He also addressed his perspective on defense planning to succeed in wars of the future.

Gen. Deptula pointed out the significant changes that have occurred in our air warfare capabilities since World War II to Dessert Storm and to the present day. Specifically, he noted the advent of stealth capabilities, the increased precision available from new munitions technology and the enhanced navigation capabilities that have significantly reduced the number of aircraft needed

a mission and the amount of munitions needed to create the desired impact on target. Modern communications also provide more rapid provision of current, accurate intelligence and the more rapid ability to make decisions. The ratio of bombers per mission has been reduced by a magnitude of 20 to 1, which provides vastly increased opportunities to engage more targets.

The increased efficiencies of communication, intelligence intercepts and reports—and the ability to operate in all weather conditions coupled with greater staff coordination—allowed improvements in operations in combat situations. On the other hand, Gen. Deptula pointed out that improved communications also allow multiple echelons of command and staff to insert themselves into the decision process, and not always to increased efficiency and speed of operations. Many in the room nodded assent. He also noted the problems in addressing the true risk from the Islamic State. The desire to respond to that threat with local national military forces may have delayed the need for more rapid response from our vastly superior force structure and the resulting degree of destruction attributed to the Islamic Force.

Looking to the future of combat, Gen. Deptula expressed concern about the relative ability of United States defense forces to keep pace with modernization of capabilities in some of our adversaries. He cited the latest defense report from the National Defense Strategy Commission composed of former top Republican and Demo-cratic officials which, released on the eve of our Gathering, stated that the United States could potentially lose a war against China or Russia. An example of new capabilities required is the need to address enhanced cyber capabilities from adversaries that could impact our response capabilities. There is concern that once again the focus is on past conflicts like insurgency and less on the future risks. All of this occurred in a time of reductions in defense spending.

The evening closed with a spirited discussion of issues and opportunities with our well-experienced Falcons Landing audience and the general. Many expressed a strong interest in having Gen. Deptula return to Falcons Landing for more discussion.

## The Gathering, December 11, 2018 Libyan/North Korean Nuclear Programs

The December Gathering featured Bill O'Connor, a retired Navy captain and civil engineering graduate of the University of Illinois (bachelor's) and Stanford University (master's). After retiring from the Navy, Bill joined the U.S. Department of Energy and worked there from 1992 until 2017; he joined the nuclear nonproliferation group in 1999.

In 2004, Bill was a team leader in removing the Libyan Nuclear Weapons of Mass Destruction (WMD). In his talk, he showed pictures of the process and how the nuclear materials were extracted and handled safely. He also showed pictures of the missiles Libya had acquired from Russia in order to put together a complete WMD program. An important aspect of this part of the presentation was the description of the activities of many international players who contributed to Libya's ability to develop their own WMD. As the on-site U.S. leader tasked with removal of the weapons and weapons-making program, Bill presented a good look at how the U.S, with help from the International Atomic Energy Agency, goes about this difficult business.

With this background, it was obvious that we had a leader when our country and North Korea reached an agreement to eventually shut down the North Korean site. Bill was appointed coleader of the ground inspection efforts at the North Korean nuclear site in Yongbyon. His time there gave him insight into not only what North Korea was doing at its home site, but also what assistance it was providing to other countries, including Syria.

With what we were able to review in pictures and his analysis of the work, it was clear that North Korea had the talent and capability to develop nuclear weapons and delivery systems.

Bill's work and analysis of the situation gave us good insights into the complexity of the negotiations that are presently on and off. North Korea has many of the same leaders in its program today that it had when Bill was there. As we watch the developments in Korea in this next year, we will have a better understanding regarding what we are seeing and hearing in the media.
